

The Plan That Combines Medicaid and Medicare

Healthy Blue + Medicare is the plan for you if you are eligible for both Medicare and Medicaid. It combines your Medicare hospital, medical and prescription drug benefits into one plan plus over \$10,000 in extra benefits at no additional cost to you. It also works alongside your Medicaid benefits to give you additional coverage when needed.

To be eligible for **Healthy Blue + Medicare** you must:

- Be enrolled in the full-benefit North Carolina Medicaid program*
- Be enrolled in Medicare Parts A and B
- Permanently reside in the service area where the plan is available
- Be a U.S. citizen or lawfully present in the U.S.

What's Included

Healthy Blue + Medicare from Blue Cross and Blue Shield of North Carolina (Blue Cross NC) gives you more benefits than Original Medicare at no additional cost to you.
